Explanation of Inland Haulage Charges (IHC) in India:

There are two practices in India with respect to Export Inland Movements as under:

| [1] | Either the Shipper pays the Railway Freight directly to the Railway Company and Line only collects Handling cost at Origin and Port/Terminal (called Shipper PDA) OR |
| [2] | Shipper will pay to the Line - Railway Freight and ICD Handling cost and Line will then pay Railway Freight to the Rail operator & ICD THC to the ICD Vendor (called LINE PDA).
An increasing number of customers are opting for Option 1 and we have eliminated maximum locations from the Second Category which is available only in One (1) location in North India i.e. DADRI and One (1) location in South India i.e. BANGALORE.
Both the options and the respective tariffs are listed in separate Sheets. |

Important Notes:

- [A] The Inland Haulage Charges apply to all Terminals at **Chennai (CITPL & CCTPL), Kattupalli, Kolkata, Krishnapatnam, Mundra (MICT, Adani CT-2, Adani CT-3 & Adani CMA), Nhava Sheva (GTI, NSDT, NFSTPL, NSICT, NSIGT & BMCT), Pipavav & Vizag covering all services.**
- [B] Inland Haulage Charges are subject to **Goods & Service Tax (GST) @ 18.0%** which applies on top of the charges. GST place of payment should be the same where such INDIA THC/THD/IHC/IHD/Local charges are collected.
- [C] IHD charges are inclusive of Port THC.
- [D] IHD Charges for OOG Special Equipment shall be declared on case to case basis.
- [E] All Special Equipment's are subject to **Empty Repositioning Cost** which shall be advised by India Corporate Logistics team on request before booking.
- [F] All charges in India will be collected under local currency **INR - Indian Rupee** as per applicable exchange rate.
- [G] The Inland Haulage Charges must always be reflected on the Manifest as a separate amount.
- [H] There have been several tariff rationalizations.
Please do not accept cargo from any other ICD's except the ICD's given in the said sheet under respective ports.
- [I] The weight updated in the sheet is taken as Gross weight (**i.e. Cargo weight + Container net weight**)
- [J] These rates are unaffected by, and do not affect, any tariff notified, published or filed in accordance with local regulatory requirements. For trades subject to the US Shipping Act or the China Maritime Regulations, application is subject to the publication and effective date requirements of those statutes / regulations. Quotations or mitigation of published surcharges that vary from ZIM's tariff shall not be binding unless included in a service contract or amendment that has been filed with the Federal Maritime Commission ("FMC") or the Shanghai Shipping Exchange, as applicable.
